

ORDER

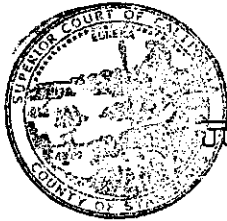
TO THE SHERIFF OF THE COUNTY OF STANISLAUS:
