

: FURTHER STIPULATION AND ORDER  
: AUTHORIZING DEFENSE EXPERTS TO  
: EXAMINE REMAINS

15 The parties stipulate to the following Order:

16 This Stipulation and Order has been agreed to by the Contra Costa County Counsel's  
17 Office.

18 The Coroner's Division of the Contra Costa County Sheriff-Coroner's Office ("Coroner")  
19 is ordered to permit defense experts selected by Kirk W. McAllister to conduct an examination  
20 of the remains of Laci Peterson and the baby Conner Peterson as follows:  
21

22 1. For purposes of this order, "examination" includes and is limited to a visual  
23 inspection (including photographs, videotapes, portable x-rays, or portable magnetic resonance  
24 imaging [MRI]), an autopsy, and the removal of reasonable amounts of tissue and/or fluid  
25 samples for testing.

1           2. The examination shall not result in any changes to the conditions of the remains  
2 beyond changes that result from a reasonable examination.

3           3. The examination will take place at the Coroner's facility at 1960 Muir Road,  
4 Martinez, California, at 9:00 a.m., August 11, 2003, or at another date and time mutually agreed  
5 to by the defense, the People, and the Coroner, and will conclude by 5:00 p.m. on the day the  
6 examination starts.  
7

8           4. Only the following persons may be present at the examination:

9               a. Up to eight persons for the defense (experts, counsel, and support persons).

10              b. Up to four persons chosen by the Stanislaus County District Attorney's  
11 Office.

12              c. Up to two Coroner officers (to maintain security and the chain of custody of  
13 the remains).  
14

15              d. A physician selected by the Coroner (to observe compliance with paragraph  
16 two).  
17

18           5. The defense shall furnish the medical instruments, sample storage containers, and  
19 portable materials and equipment (x-rays, MRI, etc.) to be used in the examination. The costs of  
20 the examination shall be borne by the defense. However, the defense shall not be responsible for  
21 the costs of having the persons identified in subparts (b) through (d) of paragraph four attend the  
22 examination. Moreover, the defense shall not be charged for the use of the Coroner's facility.



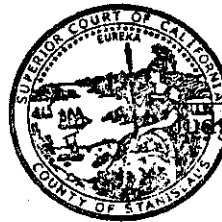


