Laci Peterson contacted me on Sept. 5 and October 31, 2002, requesting that the City close off the trail access at Covena Avenue. Mrs. Peterson stated that undesirable activity was going on at this access area, and that there were weeds, trash and graffiti that needed to be cleaned up.

I have attached the Nov. 1 e-mail to Duane Frederick, Parks Maint. Superintendent, which explains our response to Mrs. Peterson.

I personally looked at the Covena access pathway and did not find it to be particularly overgrown or in a trashy condition but did recommend some vegetation trimming for visibility, graffiti and trash clean-up, along with a street light for the end of Covena. I know that the street light did not get installed.

Please note that the Nov. 1 e-mail was originally cc'd to Sgt. Broumas and Officer Kirchoff.

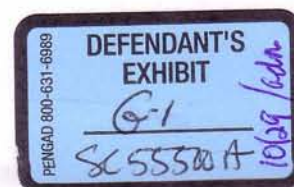
I am also forwarding an e-mail from a Jacob Schwartz of San Diego, who sends information from a psychic reading that he had regarding this case.

Duane:

Lacey Peterson of 523 Covena called again this week, asking about closing Covena Avenue at the dirt pathway which leads **down** to the park and trail. I told her that our Department wishes to keep this **access**. Ms. Peterson **proceeded** to list the **problems** that she sees with the Covena Avenue park and trail access path.

There looks to **be** approximately 300 feet of dirt path from the dead-end of Covena down to the asphalt trail. Ms. Peterson claims the path needs to have vegetation trimmed to improve visibiity, graffiti removed and trash picked up. She also asked about some lights along this path.

I think that it may help to trim the vegetation to make this path less **concealed**. Please ask **Wally** to look into the vegetation trimming, trash and graffiti removal. Perhaps a street light at the **dead-end** point of Covena would help to alleviate a **nighttime** visibility problem for police.
